


Prepare for Operational Works

Guide to Operational Works – accepted and assessable development

PURPOSE

Operational works generally occur ancillary to Material Change of Use and Reconfiguring a Lot developments. Operational works applications are required to manage construction and operational impacts on adjacent properties, the environment, infrastructure and amenity. Categories of assessment and codes applicable for operational works are outlined below.

Extracting gravel, rock, sand or soil from the place where it occurs naturally	Accepted development if undertaken by or on behalf of the Council	
Conducting a forest practice	Accepted development	
Excavating or filling that materially affects premises or their use	 Accepted development if: there would be a change of no greater than 1m in the level of any part of the site; and less than 100m³ of material is imported to or removed from the site. 	Excavation and filling code
